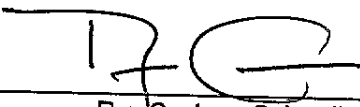
ARTICLE VIII - BY-LAWS

The power to adopt, alter, amend, or repeal by-laws shall be vested in the Board of Directors and the Stockholders.

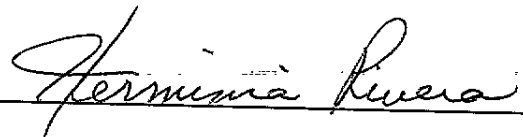
ARTICLE IX - AMENDMENT

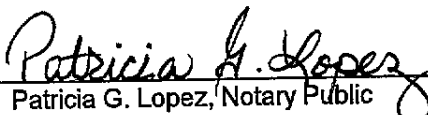

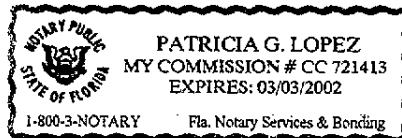
