The undersigned subscriber to these Articles of Incorporation, a natural person GENETARY OF STATE to contract, hereby forms a corporation under Chapter 607 and/or 621 of the laws of the State of Florida.

#### ARTICLE I - NAME

The name of the corporation shall be The Fudge, Inc.

#### ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address is The Shops at Stirling Place, 5869 West Atlantic Avenue, Suite A-7, Delray Beach, Florida 33484.

#### ARTICLE III - PURPOSE

The purpose of this corporation is to engage in every aspect of the business of rendering the services of the sale of ice cream, cake, candy and related items.

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.
