

## ARTICLES OF INCORPORATION BKDH ADVISORS, INC.

ALLAHASSELUK STATE The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I NAME
