# ARTICLES OF INCORPORATION OF MANJUL D. DERASARI, M.D., P.A.

The undersigned subscriber to these Articles of Incorporation, natural people competer contract and legally authorized to practice the profession of medicine in the State of Florida, hereby proceed to form a professional corporation in accordance with the Florida Professional Service Corporation Act and the Florida Business Corporation Act, and hereby adopts the following Articles of Incorporation for such corporation.

#### ARTICLE I. NAME

The name of the corporation established as a Florida Professional Association is: Manjul D. Derasari, M.D., P.A.

#### ARTICLE II. PURPOSE AND NATURE OF BUSINESS

The purpose of the Corporation and the nature of its business is as follows:

To engage in the practice of medicine and to render such services as may be ancillary to the foregoing. The corporation may purchase and own real and personal property necessary or appropriate for rendering its professional services and may invest its funds in real estate, mortgages, stocks, bonds, and any other type of investments, all in accordance with the provisions of Florida Statutes Chapter 621.

## ARTICLES III. CAPITAL STOCK

#### ARTICLE IV. DURATION

The date of the corporate existence shall begin when these Articles have been filed with the Department of State, State of Florida, according to the Statutes of the State of Florida. The Corporation shall have perpetual existence.
