This letter is to certify that the enclosed Uniform Business Report is the first notice that the corporation referenced above received. The report was received approximately two weeks prior to this letter.

In an attempt to organize my corporation my accountant and I met on August 23<sup>rd</sup> to file for an Election by a Small Corporation (Form 2553) in the midst of reviewing the corporation it was brought to our attention that the address on file with the Division of Corporations was incorrect. The address listed was the address where my ex-husbands corporation was located and at the moment of incorporating my business my Divorce Attorney at the moment assumed I was going to remain in the same location. To correct the error the accountant then began to prepare an Articles of Amendment, which I have enclosed a copy of the amendment since it was never filed.
