

ARTICLES OF INCORPORATION OF



GLOBAL RETICULUM, INC.

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I NAME

The name of the corporation is Global Reticulum, Inc.

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS OF THE CORPORATION


