I (We) the undersigned. do to hereby associate ourselves together and subscribe this Certificate of Incorporation for the purpose of forming a corporation under the laws of the Seate of Florida, and subject to the following provisions:

*****ARTICLE ONE*****

THE NAME OF THE CORPORATION SHALL BE

*****ARTICLE TWO*****

The corporation may engage in any activity or business permitted under the Laws of the United States of America and of the State of Florida

*****ARTICLE THREE*****


