**ARTICLES OF INCORPORATION
FOR
DELTA PRIME CAPITAL CORPORATION**

The undersigned sole incorporator, being a natural person competent to contract and desiring to form a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE 1. The name of the corporation is Delta Prime Capital Corporation.
