In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of this corporation is VACA ENTERPRISES INC., with its principal address at 1301 Fairlee Street, Lakeland, Florida 33813.

ARTICLE II

The existence of the corporation shall begin on the date of filing of these Articles.

ARTICLE III

The maximum number of shares this corporation is authorized to issue is ONE THOUSAND (1000), all of which shall be Common Shares. All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote

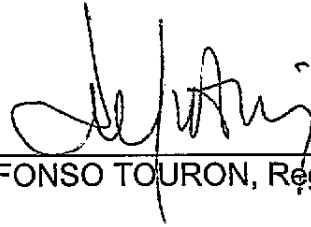
