**ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, acting as sole incorporator and director of Tech-Dragon Trade Corporation under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**

The name of the corporation is TECH-DRAGON TRADE CORPORATION.

**ARTICLE II
SHARES**

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, One Cent (\$0.01) par value per share.

TERM OF CORPORATE EXISTENCE


The Corporation shall have perpetual existence commencing on the date these Articles of Incorporation are filed with the Florida Department of State.
