ARTICLE I- NAME     The name of the corporation is Aviator Pilot & Aircraft Supply, Inc.

ARTICLE II- DURATION     This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III- PURPOSE     This corporation is organized for the purpose of transacting all lawful business in the sale of pilot, aviation and aircraft supplies.

ARTICLE IV - CAPITAL STOCK     This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

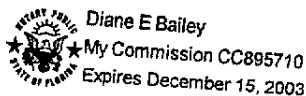


