**ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, acting as the sole Incorporator of **CREATIVE MARKETING INTERNATIONAL, INC.**, under the Florida Business Corporation Act, Chapter 607, Florida Statutes, as hereafter amended and modified, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I
Name

The name of the Corporation is **CREATIVE MARKETING INTERNATIONAL, INC.**

ARTICLE II
Business and Activities

The Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III
Capital Stock

The total number of shares which the Corporation shall have the authority to issue shall be Ten Thousand (10,000) shares, consisting of a single class of common stock having a par value of \$0.01 per share.

ARTICLE IV
Preemptive Rights

There shall be no preemptive rights with respect to new stock of this Corporation.

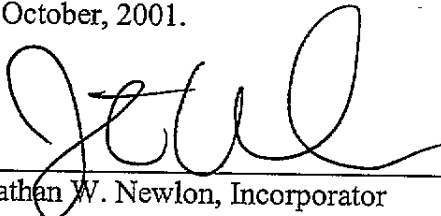
ARTICLE VIII

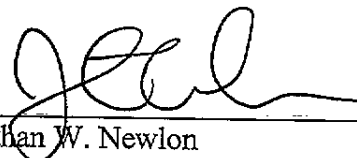
