The undersigned, acting as incorporator of a Corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

### ARTICLE I

The name of this Corporation is FEDERAL DISCOUNT STORES, INC.

#### ARTICLE !! DURATION

This Corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

#### ARTICLE III PURPOSE

The general purposes for which this Corporation is organized are the following: A. To engage in and transact any lawful business for which a corporation may be incorporated under the Florida Business Corporation Act. No other purpose limits these general purposes in any way.
