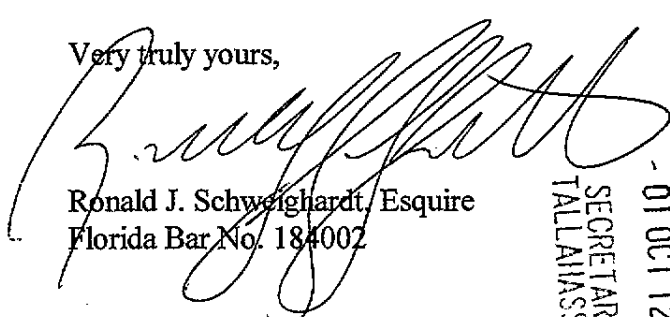

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

ZIGLET, INC.

The name of this corporation shall be ~~DUN RICE, INC.~~ and the initial address of this corporation shall be 1228 Northwest 89<sup>th</sup> Drive, Coral Springs, Florida 33071.

ARTICLE II

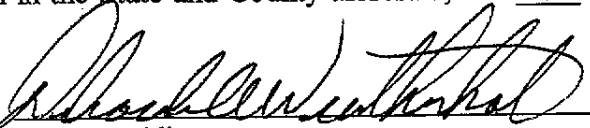
