# ARTICLES OF INCORPORATION

OF

# LAW ENFORCEMENT & SECURITY CONNECTIONS, INC.

The undersigned, desiring to form a corporation for profit pursuant to the provisions of the corporate laws of the State of Florida, does hereby make, sign, acknowledge and file these Articles of Incorporation.

# ARTICLE I - NAME

The name of the proposed corporation is:

Law Enforcement & Security Connections, Inc.

#### ARTICLE II - PURPOSE

- A. The specific business in which the corporation is to engage is to provide:
- 1. Instruction for law enforcement and security personnel covering topics such as firearms qualification and requalification for security officers applying for or re-qualifying for a Class G license issued by the State of Florida, baton training, handcuff training, defensive tactics training, pepper spray (OC) training, radar operator training, breath test operator training, breath test operator training, report writing training, retail security loss prevention training, and defensive driving training.

- 2. Instruction and training for private companies in topics including, but not limited to, work place violence, sexual harassment, armed robbery response, employee theft detection, and security procedures for bank employees.
- 3. Specific content courses for RRB Systems
  International, Inc. which include, but are not limited to, Rapid
  Rotation Baton courses, rapid cuff courses, and ground fight
  courses. These courses will be conducted locally, nationally, and
  internationally.
- 4. Retail and wholesale distribution of law enforcement and security products for RRB Systems International, Inc.
- 5. Operation of a security officer training facility to provide training for applicants applying for a Class D security license by the state of Florida.
- 6. Operation of a security company licensed by the State of Florida to devise, put into operation, and conduct ways, systems, and methods for the prevention and detection of crime and the apprehension and arrest of criminals; for the recovery of lost or stolen property; for the finding of missing persons, documents, or goods; for investigating and reporting upon the antecedents, habits, character, doings, reliability, credit, or financial condition of persons, firms, associations, or corporations.
- B. The general purpose, objects and powers of the corporation are to engage or transact any or all lawful

activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory, or nation.

- C. The corporation shall have the power to:
  - 1. Rent, lease or sell equipment;
  - 2. Contract and sub contract;
  - Own and hold franchises;
- 4. Acquire by purchase, lease or otherwise, lands and buildings and to own and hold same for the use of the corporation;
- 5. Contract, own, buy and sell or lease real or personal property;
- 6. Purchase and hold stock in corporate assets in other corporations and engage in the same or other character of business;
- 7. Guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities, or other evidence of indebtedness created by any other corporation in the State of Florida or any other state or government, and while owner of such stock, to exercise all rights, powers, and privileges of ownership, including the right to yote on such stock;
- 8. Contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidence of indebtedness, and execute such mortgages, transfers or corporate property, or other instruments to secure the payment of corporate

indebtedness as required;

- 9. Enter into, make, perform, and carry out contracts and agreements of every kind, and for any lawful purpose, without limit as to amount, with any person, firm, association, or corporation; and transact any further and other business necessarily connected with the purpose of this corporation, or calculated to facilitate same;
- 10. Carry on any or all of its operations and businesses, to promote its objects within the State of Florida, or elsewhere, without restriction as to place or amount; and to have, use, exercise and enjoy all the general powers of like corporations;
- 11. Do any or all of the things herein set forth to the same extent as natural persons might or could do, and in any part of the world as principals, agents, contractors or otherwise, alone, or in company with others, and to do and perform all such things and acts that may be necessary, profitable, or expedient in carrying on any of the business or acts of the corporation;
- 12. Aid, or receive aid, from any person, firm, corporation, business, or party whether profitable or not in any form as the stockholders or any authorized agent of the corporation shall deem necessary or compassionate.

#### ARTICLE III - CAPITAL STOCK

The aggregate number of shares which the corporation shall have the authority to issue is 1000 shares of the par value of \$1.00 each, all of one class which shall be designated as common stock. All of such stock shall be fully paid and non-assessable and shall be payable in cash, property, labor or service at a just valuation to be fixed by unanimous agreement of the subscribers hereto at the organizational meeting to be held after the granting of the charter herein applied for. The corporate officers shall issue the stock pursuant to the instructions of the subscribers.

# ARTICLE IV - MINIMUM CAPITAL

The minimum amount of capital with which this corporation shall begin business is more than \$100 Dollars.

# ARTICLE V - PERPETUAL EXISTENCE

This corporation shall have perpetual existence unless sooner dissolved according to law.

# ARTICLE VI - INITIAL PRINCIPAL OFFICE
