

ARTICLES OF INCORPORATION  
OF

ZAYNA G. GIBSON, CPA, P. A.

The undersigned subscriber, a natural person competent to contract, hereby forms a professional association under the laws of the State of Florida, and adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the professional association shall be ZAYNA G. GIBSON, CPA, P. A.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The initial principal place of business of this professional association in the State of Florida shall be 135 E. International Speedway Blvd., Daytona Beach, FL 32118. The Board of Directors from time to time may move the principal office to any other address in Florida.

ARTICLE III - NATURE OF BUSINESS

The general purposes for which the professional association is organized are:

1. To transact any lawful business for which professional associations may be incorporated under the laws of Florida;

2. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing. ALSO ACCOUNTING, CONSULTING AND FINANCIAL SERVICE;

#### ARTICLE IV - CAPITAL STOCK

The maximum number of shares of common stock that this professional association is authorized to have outstanding at any one time is One Thousand (1,000) shares, having a par value of One Dollar (\$1.00) per share.

#### ARTICLE V - REGISTERED AGENT

#### ARTICLE VI - INITIAL CAPITAL


