**ARTICLES OF INCORPORATION
OF
McPHIL LAND HOLDINGS, INC.**

The undersigned incorporator, RUPERT E. PHILLIPS, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is McPHIL LAND HOLDINGS, INC.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the corporation is 1713 Giant Sycamore Lane (P.O. Box 219), Baker, Florida 32531.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

ARTICLE IV - CAPITAL STOCK

The restrictions contained in this Article VI may be modified by a separate written agreement among the corporation and the shareholders receiving shares in the initial issuance of stock of the corporation.

ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT


