

The undersigned subscriber to these Articles of Incorporation, competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is OXEBRIDGE QUALITY RESOURCES, INC., whose mailing address is: 1025 West Lake Hamilton Drive, Winter Haven, Florida 33881.

ARTICLE II - PURPOSE
