The understyned, subscriber to these Articles of Incorporation, a natural person. competent to contract, and desiring to make and enter into the following ARTICLES OF INCORPORATION, for the purpose of forming a corporation under the laws of the State of Florida, does herewith agree as follows:

- 1. The name by which this corporation shall be known, is: GOT YOUR WATCH . COM, INC.
  - 2. This corporation shall have perpetual existence.
  - This corporation is organized for the following purposes:
- A. To buy, sell, and deal in at wholesale and retail, and to export and import jewelry of all kinds, watches, watch movements, watch cases, wrist watches, clocks, alarm clocks, floor clocks, and time keeping devises and time keeping devices of ever kind, make and description, and to acquire by construction, purchase, exchange, or other means, and thereafter to own, lease, maintain, and carry on, and to sell, transfer, convey, or otherwise dispose of real and personal property of all kinds and description, and other establishments suitable or proper for the operation and conduct of the business to be operated by this corporation.
- B. To purchase, improve, develop, lease, exchange, sell, dispose of, and otherwise deal in and turn to account, real and personal property of all kinds and description; to
