ARTICLES OF INCORPORATION

OF

UNITED COMMUNITY BANK

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of United Community Bank are hereby amended as follows:

<u>FIRST</u>: Article I of the Articles of Incorporation is hereby amended by deleting the text thereof in its entirety and substituting the following in lieu thereof:

The name of the corporation shall be Central Florida State Bank and its initial place of business shall be 11800 South U.S. Highway 441, Belleview, Florida 34420

SECOND: The foregoing amendment was adopted by the holders of in excess of a majority of the outstanding shares of common stock, being the sole voting group entitled to vote on the amendment, acting by written consent without a meeting as of Marcu 15, 2002 and the number of votes cast for the amendment was sufficient for approval by the holders of common stock.
