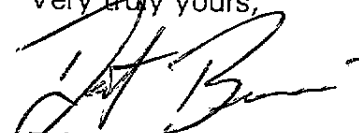

**ARTICLE I - NAME**

The name of this corporation is: CYBERNET CONCEPTS AFFILIATED, INC.
