AUTHORIZED SHARES

The aggregate number of shares of stock that this corporation is authorized to have outstanding at any one time is Six Hundred(600) shares of common stock each no par value.

<u>ARTICLE VI</u>

OFFICERS AND OTHER AUTHORIZED REPRESENTATIVES
