#### ARTICLE I

The name of the Corporation shall be:

#### SOUTHPAW TOBACCO CORPORATION

#### ARTICLE II

#### TERM OF EXISTENCE

This Corporation shall exist perpetually or until dissolved by due process of law.

#### ARTICLE III

#### **PURPOSE**

This Corporation is organized for the general purpose of transacting any or all lawful business permitted under the law of the United States and the State of Florida.

#### ARTICLE IV

#### CAPITAL STOCK

This Corporation is authorized to issue par value common stock as described below, and none other:

Maximum Number of Shares: 100

Par Value Per Share:

\$1.00

The authorized shares of par value common stock may be issued only for a consideration having a value, in the judgment of the Board of Directors, equivalent at least to the full par value of the stock so to be issued. Such consideration may be in the form of cash, real property, tangible personal property, intangible personal property, labor or services rendered, other than future services, or any combination of the forgoing.

Each share of common stock of this Corporation shall entitle the holder of record thereof to one vote upon each proposal presented at lawful meetings of the Shareholders. No holder of common stock of this Corporation shall be entitled to any right of cumulative voting.

The Corporation may provide for preemptive rights of stockholders pursuant to provisions of its By-laws, but no preemptive rights shall exist unless specifically approved for inclusion in the By-laws.
