The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**Name**

The name of the corporation is Speaking For You, Inc.

**ARTICLE II**

**Duration**

The period of existence of the corporation is perpetual.

**ARTICLE III**

**Principal Office/Mailing Office**

**Shares**

The number of shares the corporation is authorized to issue is 100 shares of Common Stock, having a par value of \$1.00 per share.

**ARTICLE VII  
Preemptive Rights**

In its discretion, and from time to time, the Board of Directors may determine that the shareholders have preemptive rights in shares issued by the Board, at a price determined by the Board. Should the Board offer preemptive rights in any portion of the shares of the corporation, whenever authorized, or any obligation convertible into shares of the corporation, the offer shall not constitute a waiver or release of the right of the Board to subsequently dispose of other portions of the shares or obligations without offering them to the shareholders.

**ARTICLE VIII  
Purposes**

The corporation is organized for the following purposes:

1. To engage in any and all lawful businesses or ventures involved in, or relating to corporate communications, product presentation and sales, and professional speaker services and training, both within the United State and Europe;

2. To own and/or lease and operate associated facilities, equipment and real estate, enter into contracts and carry on any activity or activities necessary or incidental to the accomplishment or furtherance of the purposes herein set forth;

3. To open branch offices in the United States and Europe;

4. To do everything necessary, proper or convenient for the accomplishment of any of the purposes herein set forth, and to do every other act incident thereto which is not forbidden by the laws of the State of Florida, or by the provisions of these Articles of Incorporation.
