ARTICLES OF INCORPORATION FOR ATEMI-RYU SCHOOL OF SELF-DEFENSE, INC.

The undersigned, a natural person competent to contract, subscribes to these Articles of Incorporation and hereby acts to form a corporation under the laws of the State of Florida.

ARTICLE I [Name]

The name of this Corporation shall be Atemi-Ryu School of Self-Defense, Inc.

ARTICLE II [Principal Place of Business]

The name and office or mailing address of the principal place of business for this Corporation shall be:
