THE UNDERSIGNED hereby makes, subscribes, acknowledges, and files this certificate for the purpose of becoming a corporation for profit under the laws of the State of Florida.

1. Name. The name of this corporation (the "Corporation") shall be SC Consulting, Inc.
2. Purpose. This Corporation may engage in computer consulting, financial services and any same activity or business permitted under the laws of the United States and of this State.
3. Stock. The capital stock of this Corporation shall consist of Four Thousand (4,000) shares of common stock having a par value of One Dollar (\$1.00) per share. No shareholder of the Corporation may transfer his shares of stock in the Corporation without first offering such shares of stock to the other shareholders who shall have a first right of refusal for the same terms and conditions as the prospective transfer to a prospective transferee.
4. Term. This Corporation shall have a perpetual existence.
5. Date of Existence. This date when the corporate existence of this Corporation shall begin is at the time of subscription and acknowledgement of these Articles of Incorporation, that is June 30th, 2001.

6. Address. The initial street address of the principal office and initial office of this Corporation is located at 424 E. Baldwin Road, Panama City, FL 32405 and James S. Coy, of 424 E. Baldwin Road, Panama City, FL 32405 is hereby designated as resident agent for this Corporation.
7. Number of Directors. This Corporation shall initially have one (1) director, but the By-Laws of this Corporation may provide for such increase or decrease in the number thereof as is authorized by law.

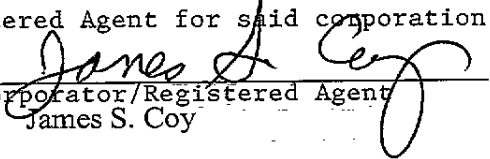

11. Regulation of Internal Affairs. The provisions for the regulation of the internal affairs of the Corporation are governed by duly adopted By-Laws.

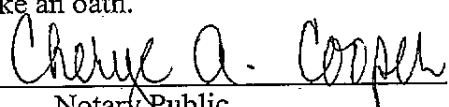
