Vertical Integration, Inc., a Florida corporation (the "Corporation"), in order to amend its Articles of Incorporation in accordance with Section 607.1003 of the Florida Business Corporation Act (the "Act"), does hereby deliver the following Articles of Amendment in accordance with Section 607.1006 of the Act:

FIRST: The name of the Corporation is Vertical Integration, Inc.

SECOND: These Articles of Amendment contain amendments to the Corporation's Articles of Incorporation, as originally filed on October 18, 2001, and as amended on November 9, 2005 (the "Articles of Incorporation"), requiring shareholder approval.

THIRD: The Articles of Incorporation are hereby amended as follows:

(a) Article I of the Articles of Incorporation is deleted in its entirety and replaced with:

"ARTICLE I. NAME"

The name of the corporation is SAVILLS STUDLEY OCCUPIER SERVICES, INC."

(b) Article VII of the Articles of Incorporation is hereby deleted in its entirety with no substitution.

(c) Article XI of the Articles of Incorporation is hereby deleted in its entirety with no substitution.

FOURTH: Each of the amendments herein was adopted and approved on April 23, 2015 (the "Adoption Date"). These Articles of Amendment were duly adopted and approved by the sole director and sole shareholder of the Corporation pursuant to Sections 607.0704 and 607.0821 of the Act pursuant to actions by written consent of sole director and the sole shareholder of the Corporation, each dated as of the Adoption Date.

FIFTH: The number of votes cast for these Articles of Amendment by the sole shareholder of the Corporation was sufficient for approval.
