ARTICLES OF INCORPORATION OF MEDINA DOLLAR STORE, INC.

The undersigned subscribers to these Articles of Corporation, each a natural person, domestic or foreign Contract, hereby associate themselves together to foreign Corporation under the Laws of Florida corporation under the Laws of Florida.
