permitted by law.



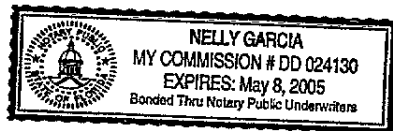
