ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is TINNEY & SON PLUMBING, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE


