**ARTICLE I – NAME**

The name of this corporation is AMERICAN PRIDE LEASING, INC., doing business at 1308 Northside Drive, Ormond Beach, Florida 32174.

**ARTICLE II – DURATION**

This corporation shall have perpetual existence commencing on the date of execution and acknowledgement of these Articles Of Incorporation.

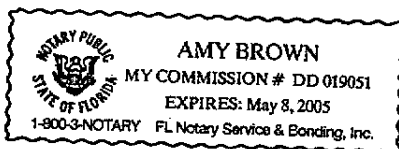

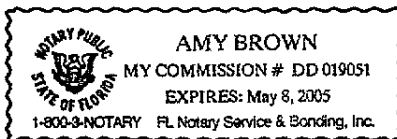
