ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I

EFFECTIVE DATE

NAME

Section 1.1 Name. The name of the corporation is CashFlow XpressChex, Inc.

ARTICLE II

PRINCIPAL OFFICE

Section 2.1 <u>Principal Office</u>. The street address of the principal office, mailing address, and the initial registered office of this corporation is 5311 San Juan Avenue, Jacksonville, Florida 32210, and the name of the initial registered agent of this corporation at that address is Lee Q. Ahr.

ARTICLE III

PURPOSE

Section 3.1 <u>Purpose</u>. This corporation is organized for the purpose of transacting any or all lawful business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV

SHARES

Section 4.1 <u>Authorized Capital</u>. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 1,000 shares of voting common stock having a par value of \$1.00 per share.

Section 4.2 Restrictions on Transfer of Stock. The shareholders may, by agreement or bylaw provision, impose such restrictions on the sale, transfer, or encumbrance of the stock of this corporation as is deemed necessary.

ARTICLE V

DIRECTORS

Section 5.1 <u>Number</u>. This corporation shall have one director initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one, or more than ten.
