**ARTICLES OF INCORPORATION
OF**

M & P JET TECH, INC.

The undersigned, for the purpose of forming a corporation, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is M & P Jet Tech, Inc., and its address is 180 N.E. 12 Avenue Apt. 15C, Hallandale Beach, Florida 33009.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

PURPOSES

The general purposes for which the corporation is organized are;

- (1) To transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.
