I. Name: SCGI Construction Company Inc.

II: Duration:

This corporation shall have perpetual existence commencing on the date of Execution and acknowledgment of the articles contained herein.

III. Purposes:

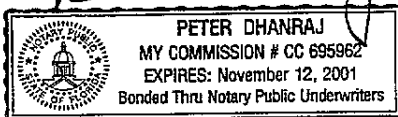
