ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Hamlet Cleaner

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 4051 W. Atlantic Avenue Delray Beach, Florida 33445

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
