ARTICLES OF INCORPORATION OF SKYJAC13, INC.



ARTICLE 1 - NAME

The name of this corporation shall be **SkyJac13**, **Inc.** The mailing address shall be 510 S.E. 9th Street #8, Fort Lauderdale, Florida 33316.
