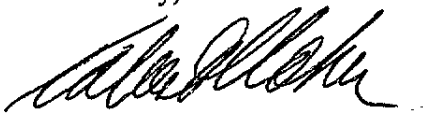

**ARTICLES OF INCORPORATION
OF
M L H INVESTMENTS CORP, INC.**

ARTICLE I - NAME

The name of this corporation is M L H Investments Corp, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 301 S. Milwee St., Longwood, Fl. 32750 and may be changed and a principal office established and/or relocated without amending these Articles of Incorporation.

ARTICLE III - PURPOSE

This corporation is organized for the purposes of investments and consulting.

ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE V - CAPITAL STOCK

VIII - PREEMPTIVE RIGHTS

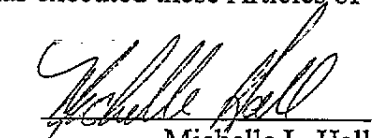
The shareholders of this corporation shall be, and are hereby vested with, preemptive rights as to their shareholdings in this corporation.

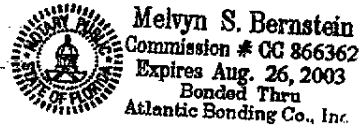

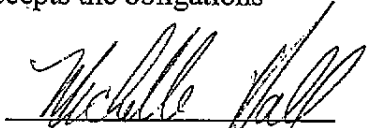
