

**ARTICLE I
CORPORATE NAME**

The name of this corporation is ATI USA, Inc.

**ARTICLE II
NATURE OF BUSINESS AND POWERS**

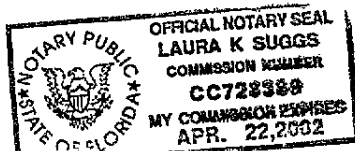




