

**ARTICLES OF INCORPORATION

THE UNDERSIGNED, acting as the sole Incorporator of **J & D FABRICATION, INC.**, under the Florida Business Corporation Act, Chapter 607, Florida Statutes, as hereafter amended and modified, hereby adopts the following Articles of Incorporation for such Corporation:

**ARTICLE I**  
Name

The name of the Corporation is J & D FABRICATION, INC.

**ARTICLE II**  
Business and Activities

The Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE III**  
Capital Stock


