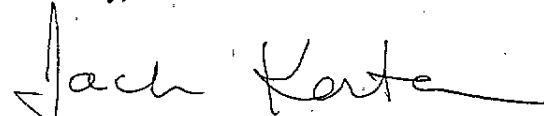

ARTICLE I - NAME

The name of this Corporation shall be:

ARTICLE II - DURATION

ARTICLE III - PURPOSE

ARTICLE IX - AMENDMENT

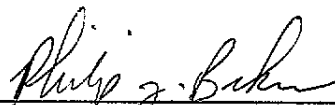

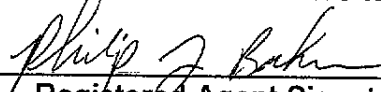
