**ARTICLE I - CORPORATE NAME**

The name of this corporation is **SOUTHEASTERN ATLANTIC PRECAST, INC.**, whose principal office and mailing address is **2909 Lancaster Road, Melbourne, Florida 32935.**

**ARTICLE II - NATURE OF BUSINESS AND POWERS**

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.


