ARTICLE I - CORPORATE NAME

The name of this corporation is **SOUTHEASTERN ATLANTIC PRECAST, INC.**, whose principal office and mailing address is **2909 Lancaster Road, Melbourne, Florida 32935**.

ARTICLE II - NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.




