# **ARTICLES OF INCORPORATION OF**

**John Provencal, Inc.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

## **ARTICLE 1. NAME**

The name of the corporation shall be: John Provencal, Inc.

## **ARTICLE II. NATURE OF BUSINESS**

This corporation may engage or transact in the business of any legal business in the state of Florida.



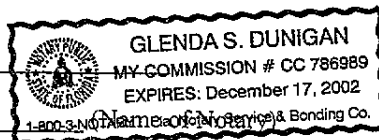
