## ARTICLES OF INCORPORATION OF

STANLEY BARNABUS STUDIOS, INC.

The undersigned, for the purpose of forming a corporation under the Ftorfida Esusiness Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE ONE

The name of the Corporation is STANLEY BARNABUS STUDIOS, INC. The mailing address of the corporation is 2825 Pinecrest Street, Sarasota, Florida 34239.

#### ARTICLE TWO

The duration of the corporation is perpetual.

#### ARTICLE THREE

The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

#### **ARTICLE SIX**

The number of Directors constituting the initial Board of Directors is THREE (3) Directors. The number of Directors may be increased or decreased from time to time, but shall never be less than three. The names and addresses of the initial Directors of the Corporation are:

#### ARTICLE NINE

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon them, and any right conferred upon Shareholders is subject to this reservation.

#### **ARTICLE TEN**

In accordance with Section 607.0203, Florida Statues, the date when this corporate existence shall commence is October 18<sup>th</sup> , 2001.
