

ARTICLES OF INCORPORATION
OF

INITIAL REGISTERED OFFICE AND AGENT



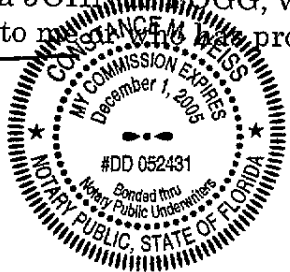
