ARTICLES OF INCORPORATION OF

The undersigned subscribers to these Articles of Incorporation being natural persons competent to contract, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

| ARTICLE II | |

This corporation shall be organized for the purpose of conducting and engaging in any lawful business activity that is not inconsistent with the laws of the State of Florida and the United States of America. The general powers of the corporation include but are not limited to the following:

(1) To sue and be sued, complain, and defend in its corporate name;

- (2) To have a corporate seal, which may be altered at will and to use it or a facsimile of it, by impressing or affixing it or in any other manner reproducing it;
- (3) To purchase, receive, lease, or otherwise acquire, own, hold, improve, use, and otherwise deal with real or personal property or any legal or equitable interest in property wherever located;
- (4) To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, and otherwise dispose of all or any part of its property;
- (5) To lend money to, and use its credit to assist, its officers and employees in accordance with Florida Statute 607.0833;
- (6) To purchase, receive, subscribe for, or otherwise acquire; own, hold, vote, use, sell, mortgage, lend, pledge, or otherwise dispose of; and deal in and with shares or other interests in, or obligations of, any other entity;
- (7) To make contracts and guarantees, incur liabilities, borrow money, issue its notes, bonds, and other obligations (which may be convertible into or include the option to purchase other securities of the corporation), and secure any of its obligations by mortgage or pledge of any of its property, franchises, and income and make contracts of guaranty and suretyship which are necessary or convenient to the conduct, promotion, or attainment of the business of a corporation the majority of the outstanding stock of which is owned, directly or indirectly, by the contracting corporation; a corporation which owns, directly or indirectly, a majority of the outstanding stock of which is owned, directly or indirectly, by a corporation which owns, directly or indirectly, the majority of the outstanding stock of the contracting corporation, which contracts of guaranty and suretyship shall be deemed to be necessary or convenient to the conduct, promotion, or attainment of the business of the contracting corporation, and make other contracts

of guaranty and suretyship which are necessary or convenient to the conduct, promotion, or attainment of the business of the contracting corporation;

(8) To lend money, invest and reinvest its funds, and receive and hold real and personal property as security for repayment:

(9) To conduct its business, locate offices, and exercise the powers granted by this act within or without this state;

(10) To elect directors and appoint officers, employees, and agents of the corporation and define their duties, fix their compensation, and lend them money and credit;

(11) To make and amend bylaws, not inconsistent with its articles of incorporation or with the laws of this state, for managing the business and regulating the affairs of the corporation;

(12) To make donations for the public welfare or for charitable, scientific, or educational purposes;

(13) To transact any lawful business that will aid governmental policy;

(14) To make payments or donations or do any other act not inconsistent with law that furthers the business and affairs of the corporation;

(15) To pay pensions and establish pension plans, pension trusts, profit-sharing plans, share bonus plans, share option plans, and benefit or incentive plans for any or all of its current or former directors, officers, employees, and agents and for any or all of the current or former directors, officers, employees, and agents of its subsidiaries;

Determination of any action, suit or proceeding by judgment, order, settlement or conviction

shall not create a presumption that the person acted with gross negligence or willful misconduct.

The determination of whether a person acted within the standard described above shall be made

in one of the following matters:

i. A majority vote of a quorum of directors who were not parties to the action, suit, or

proceeding; or

ii. If a majority of the disinterested directors so requests, by independent legal counsel in

a written opinion, or

iii. If a majority of the disinterested directors so requests, by a qualified independent

arbitrator.

Success on the merits in defense of any action, suit or proceeding shall be determinative that the

person acted within the necessary standard of conduct and no further determination shall be

necessary.

Expenses, including attorney's fees, incurred in defending a civil or criminal action, suit or

proceeding may be paid by the Corporation, in advance of the final disposition of such action,

suit or proceeding, upon a preliminary determination by the disinterested board members that the

person did not act with gross negligence or willful misconduct, upon receipt of an undertaking by

such person to repay such amount upon any ultimate determination that he acted with gross

negligence or willful misconduct.

Indemnification as provided hereunder shall continue as to a person who has ceased to be a

director, officer, employee or agent and shall insure to the benefit of his heirs, executors,

administrators, and assigns.

The Corporation shall have the power to purchase and maintain insurance on behalf of any

person who is or was a director, officer, employee, or agent of the Corporation, or is, or was

serving at the request of the Corporation as a director, officer, employee, or agent of another

corporation, partnership, joint venture, trust, or other enterprise, against any liability asserted

against him and incurred by him in any such capacity, or airing out of the status as such, whether or not Corporation has the power to indemnify him against such liability under the provisions of this section.
