#### ARTICLES OF INCORPORATION

OF

#### HIPPO-PATRIOT, INC.

ARTICLE 1 - NAME

The name of this corporation shall be:

HIPPO-PATRIOT, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE -

# ARTICLE XIII - MANAGEMENT OF CORPORATION BY SHAREHOLDERS

All corporate powers shall be exercised by or under the authority of, and the business and affairs of this corporation shall be managed under the direction of, the shareholders of this corporation.

#### ARTICLE XIV - POWERS

This corporation shall have all the corporate powers enumerated in the Florida General Corporation Act.

#### ARTICLE XV - DIRECTORS RESIDENCY AND COMPENSATION
