ARTICLES OF INCORPORATION

OF

United Praise Management, Inc.

The undersigned, for the purpose of forming a corporation under the Florida General corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is United Praise Management Inc.

ARTICLE II - NAME

The duration of the corporation is perpetual.

ARTICLE III- PURPOSE

The general purposes for which the corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the corporation or necessary or desirable in order to accomplish them.
- C. The general nature of the business to be transacted by this corporation shall be any activity or business permitted under the laws of the United States of America and the State of Florida.

ARTICLE IV- CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue in One Hundred (100) shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

ARTICLE V - INITIAL PRINCIPAL OFFICE AND REGISTERED AGENT

The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one. 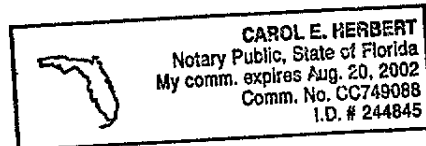
