ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

#### ARTICLE 1

#### NAME AND ADDRESS

Section 1.1 Name. The name of the corporation is Absolute Off-Road Recovery and Towing, Inc.
