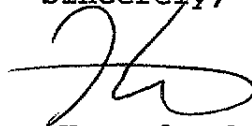

**ARTICLE I - NAME**

The name of the corporation is All Data Auto Machine Shop,  
Inc.

**ARTICLE II - DURATION**

This Corporation shall have perpetual existence commencing on

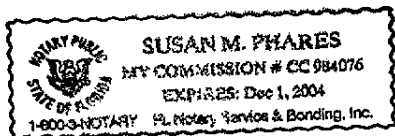


